OUTSIDE/LOWER

A: \$70/month (8'h x 4'w x 6'd + area under stairs)

B, C, D, D2: \$65/month (8'h x 4'w x 6'd)

OUTSIDE/UPSTAIRS

E, F, G, H, I, O: \$55/month (6'h x 3'w x 3'd)

INSIDE/UPSTAIRS

#1 – 18: \$40/month (43" h x 31" w x 31" d)

#31 – 42: \$40/month (41" h x 30" w x 32" d)

INSIDE/DOWNSTAIRS BY ELECTRONICS LAB

#43 – 57: \$20/month (22" h x 12" w x 30" d)

INSIDE/DOWNSTAIRS BY WOOD SHOP

#19 – 30: \$50/month (43" h x 31" w x 31" d)

Storage Rules and Etiquette:

Renter acknowledges that he/she is solely responsible for the security and safety of their property. Renter has carefully inspected the storage space designated above for full suitability to his/her purposes. Renter acknowledges and agrees that MakerPlace is not responsible for stolen, lost, or damaged property. Renter may provide her/his own lock to secure the designated rented facility. Renter acknowledges that MakerPlace is not responsible for providing a lock. Renter agrees that locks, if any, will be removed no later than the last day of the rental period. Storage area contents remaining after the rental period may be disposed of in partial payment for accrued rental fees and/or other charges without notice.

Renter agrees that illegal, radioactive, dangerous, caustic, poisonous, flammable, explosive and/or toxic materials will not be stored in the MakerPlace storage facilities. With management approval, some flammable substances may be stored in the flammables locker located in the paint spray room. Renter agrees that all damage caused by material stored in the assigned locked is solely the responsibility of renter. Renter acknowledges that storage space at MakerPlace is only for the use of active members in good standing and that this agreement will terminate simultaneously with renter's active membership lapsing.

Renter agrees not to modify the designated rental space in any way without written management approval. Shelves may be added or deleted upon request to management.
